Income-tax Ordinance, 1984 Page 24 income-tax shall be charged at the rates specified in the Second Schedule in respect of- (i) a non-resident person, not being a company; (ii) any income classifiable under the head “Capital gains”; and (iii) any income by way of “winnings” referred to in section 19(13).
